Indian Council of Medical Research (ICMR) is an Autonomous Organization under Department of Health Research, Ministry of Health & Family Welfare invites **online application(s) up to 21st August, 2017 till 5.30 PM** for Eight Posts of Director at the following Institutes/Centres in Pay Band-4 Rs.37400-67000 plus Grade Pay of Rs.10000 / Level 14 of 7th CPC Pay Matrix and usual allowances as admissible to ICMR employees:-

3. The posts are with all India transfer liability under the Council.

4. **Essential Qualification & Experience**

- (i) Postgraduate degree in medical subjects recognized by MCI or Doctorate degree in Life/Biological Sciences or relevant subjects from a recognized University.
- (ii) Sixteen years R&D experience in the relevant areas in a recognized institute(s) after obtaining essential qualification, out of which at least 5 years in a managerial position to handle R&D projects independently, in a team effectively in directing position including 2 years regular service in Grade Pay of Rs.8900/-.

Desirable Qualification:

- (i) Additional Post doctoral research/teaching experience in relevant subjects after MD/Ph.D in recognized institute(s)
- (ii) Knowledge of Computer Applications or Business Intelligence tools/Data Management

5. **Age limit:**

Between 45 years to 58 years. The crucial date for determining the age limit shall be as per the guidelines of Department of Personnel and Training issued from time to time. However, the prescribed age may be relaxed in exceptional cases for experienced and qualified candidates by DG, ICMR.

6. **Fee:**

Application Fee of Rs. 500/- (Rupees five hundred only) for general and OBC candidates including ICMR employees is required. SC/ST/Women/PWD candidates are exempted from application fee. Application Fee is to be paid by candidates through **Crossed Demand Draft (DD)** in favour of **Director-General, ICMR**, payable at **New Delhi**.

7. **How to apply:**

- i) Candidates should apply **online** through <http://www.icmr.nic.in> upto 21st August, 2017 till 5.30 PM.
- ii) Following self attested required documents are to be enclosed with the **printout of online application :-**
 - a) Proof of Date of Birth
 - b) Educational qualifications
 - c) Experience
 - d) Caste Certificate (wherever applicable) etc.
- iii) The printout of the online application (Hard copy of Application filled through online) duly signed by the candidate and recent passport size photograph affixed on it alongwith Demand Draft towards application fee and all required documents should be sent to the **Deputy Director General (Admn.), Room No. 404, 3rd Floor, Indian Council of Medical Research, P.O. Box No. 4911, V. Ramalingaswami Bhawan, Ansari Nagar, New Delhi- 110029 (India)** on or before 31st August, 2017 till 5.30 PM. The name of the post and Institute/Centre for which the candidate applies must be mentioned on the top of the envelop.

8. Other conditions:

- (i) Separate online application and printout of the same should be submitted for each post alongwith separate Demand Draft.
- (ii) Application received after the closing date for whatever reason is liable to be rejected.
- (iii) In the event of any false information furnished or suppression of any material in the application comes to notice at any time during the service of a person, his/her service would be liable to be terminated.
- (iv) Application unsigned/incomplete or without supportive documents is liable to be rejected.
- (v) Printout of the online application (Hardcopy) from employees working in Centre/State Government Department/Public Sector Undertakings & Govt. funded research agencies must be forwarded through proper channel along with the certificate of the employer that the applicant will be relieved within three months of his/her receipt of appointment order. Advance copies of application will be considered subject to the condition that a 'No Objection Certificate' from the employer is produced at the time of personal discussion.
- (vi) Any outside influence (political or otherwise) brought in by a candidate shall disqualify him/her.
- (vii) Any matter for which no specific instruction has been given shall be decided by ICMR and the decision shall be final and binding on the candidates.
- (viii) Any further detail/communication shall be displayed on ICMR website only.
