This refers to ICMR Advertisement No.ICMRHQ/Pers/2018/02 dated 8/11/2018 regarding filling up the posts of Scientists-D, Scientist-E and Scientist-F under the ICMR Hqrs. and its Institutes/Centres.

Competent authority has decided to hold the personal discussion/interview for the posts of Scientist-E (Non-Medical) from 20-22 May, 2019 and 28-30th May, 2019 at 9.00 A.M. at ICMR Hqrs., N. Delhi.

- On 29th May, 2019 at 9.00 a.m. from S.No. 161 to 200.
- On 30th May, 2019 at 9.00 a.m. from S.No. 201 to 214.

All the eligible candidates listed in Annex.I are requested to appear for personal discussion as per above scheduled dates at Indian Council of Medical Research, V. Ramalingaswamy Bhawan, Ansari Nagar, New Delhi-110029, along with following documents:-

- a. All original certificates including the R&D/teaching/managerial experience certificate as per the advertisement and claimed in their application. The experience certificate should clearly indicate the designation/post held, pay/remuneration, period and nature of job so as to cross check again the eligibility in this regards.
 - b. One Identity Proof (in original) with photo i.e. Aadhaar Card/PAN Card/Voter ID card etc.
 - c. List of Publications (alongwith copy)/ Awards/ Extramural Projects
 - d. If the application was not forwarded through proper channel, "No Objection Certificate" from their present employer (or Director/Officer-in-Charge in case of ICMR employee), for consideration of their candidature for the said post. In case they do not furnish the same for some reasons or other, they will not be considered for the said post and will not be entitled for T.A. claim from ICMR.
 - e. One page write up of the work done (10 copies)
2. They will be paid 2nd class return rail fare through shortest route. In order to make speedy payment of their TA, they are required to bring duly filled Mandate Form (copy attached) along with copy of cancelled cheque. No spot payment will be made.
 3. They have an option to answer in Hindi/English during the personal discussion/interview.
 4. Their candidature for Personal discussion/Interview is provisional and subject to fulfilling all eligibility conditions/requirements as prescribed for the post & claimed by them in application.
 5. Canvassing directly or indirectly will disqualify the candidature.
 6. ICMR reserves the right to cancel the process, if considered necessary at any stage of selection/appointment.
